

World War 1 Event

As with the WWII Days event at Midway Village Museum in Rockford, Illinois, which has become one of the largest WWII events in the country, the museum is now working with WWII re-enactors who also do WWI to create the largest public Great War public battles and encampment in the country. Now in its second year, this year's Great War event April 10, 11, 12 and 13, 2014 will celebrate the 100th anniversary of the start of WWI. There were 132 WWI re-enactors who attended in 2013 and the number is expected to grow to 200 this year.

All impressions welcome to help tell the story of the Great War through 1914-1918.

Thursday April 10 is a set up day and work day on the trenches and battlefield. Friday will be a school display day for school groups in the morning. All impressions welcome to help tell the story of the Great War through 1914-1918. The event includes battles in the historic town, indoor and outdoor displays, and large field battles (including gas attacks) are centered on a 100 foot long permanent trench, which contains 3 sleeping bunkers firing steps and MG positions.

Food tickets are provided by the museum that are good at the WWI French cafe set up in the hotel in the downtown. The cafe offers warm drinks and authentic French food. Vendors selling WWI gear will be set up in the main red barn.

WWI was a major turning point in social history, as it brought to the forefront equal rights for women, as they worked in the factories and farms to fill the jobs of soldiers who marched off to war. Women attending the event are encouraged to help with the womens' suffrage marches and rallies through town. There is also a separate Facebook page set up to help women build their impressions with photos, references, patterns and discussion.

The website offers links to vendors and lists of basic gear needed for several impressions. It also lists units that attend the Rockford event — most made up of WWII re-enactors from the Midwest.

Old Business

Living History on Historical GroundBy Bodo Fehrmann

When one thinks of the Ardennes and the Battle of the Bulge, certain images come to mind - dense evergreen forests, low hanging fog, steep terrain, and the ominous profile of the German Stahlhelm silhouetted in the dim forest light as men cloaked in heavy field gray uniforms spearhead the final major German offensive of the Western front-Wacht am Rhein.



One can imagine the difficulty recreating the terrain, atmosphere, and eerie silence of the Ardennes for a reenactment event. Sites must be carefully scouted and chosen if one desires to create a truly realistic "Battle of the Bulge" experience for reenactors.



A few groups overseas, however, know not of this plight, as they hold events every year in the real Ardennes, walk the same ground as the brave men 70 years before them did. One of these groups, known as "Fronthistoriska Föreningen" (Frontline Historical Association) has members who portray a multitude of impressions varying from Waffen-SS, German Army, Soviet troops, and Commonwealth forces. What sets this group, and a few others in the region, apart from most reenactors worldwide is their seemingly obsessive attention to detail. When examining photographs from this group, one is hard pressed to find mistakes, anachronisms, or to put it in reenactors' terms, "Farby" items. For an organization with members in several European countries (most are based in Sweden), it is awe inspiring to see a reenactment organization holding themselves to such exacting standards.



Interview with Daniel Olsson, FHF

1. How did the organization get started?

The first German WWII reenactment group in Sweden started during the year 2000 and many of FHF's members began their reenactment career there. In 2008 after too much group politics and lack of ambitions, people left the old group and FHF was created. In FHF we decided to set focus to camaraderie and accuracy and have worked consistent to maintain this culture.

2. Is it difficult to find members who are willing to get such high quality impressions?

Over the years since FHF started in 2008 we have got new members on a regular basis, one or two a year sometimes more. Right from the beginning when a new member joins us we present a "kit list" that we have in FHF. Not only is the basic equipment listed, but also where we think you can buy the best reproductions. Since we have motivated and skilled members, the search for better and more accurate equipment and uniforms is always in motion and any new member is quickly introduced, and kind of absorbed by this thrive to learn and look authentic. To answer your question, it is in my point of view not that difficult to find members that are willing to get high quality impression because we all help each other to get better and boost each other to do their best and look good. Low standard and bad gear is just not an alternative, something to be proud of!

3. What is it like reenacting on the same ground that the War was really fought on?

Beside the Ardennes (Belgium and Luxemburg), we have members who have been to Slovakia, Denmark, Russia and England to participate in different events. Apart from England all events have occurred on historical ground and sometimes even on real battlegrounds. To reenact where soldiers actually have lived, fought and died during WWII gives an extra dimension that is hard to describe. Your mind is often full of questions such as "What happened right on this spot?" and so on. Humbleness and respect are two words that could summarize the overall feeling quite well.



4. Which supplier for reenactment gear is FHF's favorite? Is there any supplier that is particularly terrible?

FHF buys uniforms and equipment from many reenactment vendors online from mostly Europe and the USA. Some suppliers are far better than others and sell quality reproductions of both uniforms and equipment. Even so, all things can't be found in stores, so some things we buy from private sellers on eBay, mostly original items.

The top favored vendors are At The Front Shop, SM Wholesale, Panther-Store and What Price Glory, which offer a wide range of top quality products.

5. What are weapons laws like?

The weapon laws are quite harsh in Sweden, and do cause some problems for us when it comes to using blank fire weapons. This category of weapons is in a sort of limbo state and there are really no clear laws about these so the police (which manage all weapon licenses) tend to deny the use of them.

Moreover we can't import deactivated weapons because the police and law view these as live weapons. So our most realistic option is to apply for what is called "collectors license".

Otherwise we use mostly replicas and airsoft guns when we are in displays and such.

6. Is it difficult coordinating several units to put together high quality events?

To coordinate several different groups is always a challenge but at the same time very rewarding. If we want the hobby to grow and expand it is vital for all of us to be able to support and work together. In FHF we have a good relation with several groups from other European countries and we put much effort in participating in events outside Sweden. There are many groups that share our goals and ambitions to take this hobby to the next level, and that serves as an inspiration for us. The most important thing is for everyone to have a clear picture of the goals you want people to achieve. You should always try to aim as high as possible. High goals serve as inspiration and feeds ambition. People are always going to want to be good enough, by demanding high standard that is what you will get.

You may be asking, "What makes these guys so great?" Look at their photographs and see for yourself. You won't find any modern eyeglasses, postwar footwear, or converted post war uniforms. You won't see incorrectly patterned breadbags, postwar mess tins, or guys covering their chests in outrageous proportions of self-awarded medals.

Yanks of the 401 GIR Land Behind Enemy Line in Holland September 18, 1944

The Yanks, flushed with victory today, have landed behind Axis lines and secured several of their objectives along the way. These United Press reporters bring you the story first hand of the brave American Glider troops who land behind enemy lines with only the equipment they are carrying on them. They must fight to secure the landing zones for the rest of the Glider troops coming in behind them with the heavy equipment.

These gliders, made of canvas and aluminum tubing, are able to carry jeeps and anti-tank guns which allow the troops to achieve their objectives. The glider men have several advantages over paratroopers as they could land on the ground intact and combat ready, enabling them to fight as soon as they disembarked the glider. The gliders are completely silent in both flight and landing so they are able to land undetected at night, thereby maintaining the element of surprise.

There are some disadvantages to using gliders on operations in that they required a smooth landing area. The Germans in Normandy have been known to place posts strung with wire in the fields known as "Rommel's Asparagus" to hamper glider landings. The gliders themselves are fragile and the landings can be very rough with many of the troops receiving broken arms and legs. When the gliders are being towed they are very vulnerable to ground fire or being shot down by enemy air craft. Additionally, the glider pilots are very expensive to train and to replace. These pilots have also suffered heavy casualties in the landings and the heavy fighting that follows on the ground.

One other disadvantage of the glider troops was the lack of incentive for this very dangerous branch of service. They dress similar to the regular infantry, though occasionally may mix some parts of their uniform with that worn by paratroopers. However, they originally did not receive the additional jump pay nor any special equipment previously reserved for paratroopers. Thankfully, The U.S. Airborne High Command has looked into this matter and adjusted it. Now, after the Normandy landing, the glider troops have been issued the same equipment, jump boots, and the pay scale has been adjusted to include the additional jump pay.

The US glider troops primarily use the CG4-A Waco Glider which is crewed by a pilot and co-pilot, and can carry a squad of fully equipped infantry or a 75mm howitzer. The Waco is 48ft 8in long with a wingspan of 83ft 8in. It can carry up to 4197 pounds of men and equipment. The maximum speed the glider can travel is 150 mph, with a cruising speed of 72 mph and a stall speed of 49 mph. The Waco Glider would sink at a rate of 400 ft. a minute and required 600-800 ft. for a normal landing.

The 401st GIR, the battle hardened unit our correspondents are traveling with, has had a long history. They were organized in March 1918 but were never called into active duty during the First World War. During the demobilization that followed the war the regiment was assigned to the 101st division as reservists. The 101st was chosen to become the second of two airborne divisions. On August 16, 1942 the 401st was recommissioned as an Airborne Infantry Regiment at Camp Claiborne La. The 401st Infantry Regiment would consist of two battalions that would land in gliders.

From 1942 until July of 1943 the 401st would train in the United States. In the 1st part of September the regiment would deploy to England their new camp would be a town called Reading about 35 miles from London in the county of Berkshire.

In England the regiment's training continued with different exercises for the preparation of the invasion of the European mainland. In March of 1944 the 401st was separated. The 1st battalion stayed in the 101st division but was sent to the 327th GIR as their 3rd battalion. The 2nd battalion was sent to the 82nd airborne division and assigned to the 325th GIR as the 3rd battalion.

In operation Overlord the 401^{st} landed on LCVPs with the 4^{th} infantry division at Utah beach instead of landing in gliders because there was a shortage of transatlantic cargo capacity at the time. The 401^{st} landed on June 6^{th} 1944 with the 4^{th} ID in the Uncle Red sector, they had orders to link up with the paratroopers that had dropped earlier in the day.

Once the 401st linked up with the rest of the 101st by June 8th they fought side-by-side and would aid in the capture of Ste. Come-du-Mont and later in the victory at Carentan. On June 15th the 1st battalion of the 401st joined the VII corp. on Utah beach and linked up with the 175th infantry Reg. of the 4th Infantry Division at Auville-sur-le-Vey. After the 401st saw 33 days of bitter fighting in Normandy they were sent back to England to refit and retrain replacements for the regiment. It was during this time they were issued new equipment and uniforms just like their airborne bothers.

On September 17, 1944 the 1st battalion of the 401st landed behind enemy lines in Operation Market Garden. The 101st used 933 gliders with 750 getting to their landing zone or within one mile of it. Here the 401st would fight for 72 long days. They fought mainly in the Zon-Veghel area of Holland, keeping open the corridor that the British XXX corp. was using to travel northward. Once the regiment was relived again they were sent back to regroup, retrain and refit with new members.



While in reserve the Regiment was called upon to stem the Axis advance in Belgium, later known as the Battle of the Bulge. The 401st was sent in on trucks but not with enough winter clothing or ammunition. Even lacking these necessary items the 401st set up a defensive line in the western perimeter of Bastogne and stopped attack after attack. On a side note, the movie "Battleground" is about the men of the 401st and their fighting at Bastogne. The Germans sent a surrender note through the lines of the 401st to the commander at Bastogne. The commander wrote a simple reply: NUTS.



The next day the low hanging clouds receded for a short time and allowed a drop of supplies of food, ammo and medical equipment. Later in the drop, gliders with heavy equipment and medical personnel were landed. On Jan 18th 1945 the 401st was pulled out of the line and sent to France for the 3rd time to refit, and retrain new personal.

In late march of 1945 the 101AB was sent into Germany's industrial area, known as the Ruhr, to mop up and capture Berchtesgaden. Upon achieving this objective the 401^{st} stayed in the area for the rest of the war.

The reenacted Modern C Company of 401st Glider Infantry Regiment is today a unit in the World War Two Historical Reenactment Society. The unit was formed in 2003 and chartered in 2004. It has members in Iowa, Illinois and Wisconsin. At the start of the new unit's history it had a mix of both Glider and Parachute interpreters. Robert Blecke, one of the early members of the HRS unit, started out in the unit as a corporal then went on to become a sergeant as the unit acquired more members. By the time Mr. Blecke had reached the rank of sergeant the unit had enough members to split off and form a unit of their own. Mr. Blecke has been involved in living history from over ten years and he is one of the few members of the unit who continues to only portray one time period.

One of the main reasons the men of C Company chose the glider impression was that very few people actually realized the United States Army used gliders in combat, most people only think of the Paratroopers. C company currently has about two dozen members spread over 3 states in the upper Midwest. One of the other members is Marc Miller, whose wife is working for the United Press and is writing this article. Marc started in WW2 living history when his wife purchased him an M1 Garand for Valentine's Day. After shooting the weapon he fell in love with it and started collecting WW2 equipment. After coming out to the Rockford event in 2010 both he and his wife decided to join the HRS. The rest, as they say, is history.

We also spoke with Craig Mickelson, another of the early members of the unit. We asked him about how the unit came to be formed in the HRS. Craig told us how several of the men were returning from a Civil War event and the discussion of picking up another time period came up. The men had originally thought of interpreting World War One. The more that they talked about it they realized that there was not much in the reproduction line being made for that particular period. This would mean a large investment and use of original equipment. Thus they decided to give World War Two a try. If you sat down with each member you would discover many varied reasons they joined up, but at the heart of each is a love of history and a constant desire to educate the public on these lesser known but no less heroic young men. Thus here today we have the reenacted C Company of the 401 Glider Infantry Regiment.

WWII Re-Enacting: Starting from Scratch

WWII re-enacting is an extremely fun and rewarding hobby but has its share of difficulties – especially for aspiring youth. Even the most enthusiastic young recruits will find the expense of compiling their impression, limited transportation to and from events, and the inexperience that naturally comes with being "green" daunting. When I entered our hobby last year I faced all of these obstacles but was able to overcome them with this simple, two-point, common sense strategy that all new re-enactors can implement to ensure success:

After deciding to become a re-enactor, and have chosen the nation of your impression, it is best to search for units nearby. A complete list of WWII HRS units can be found on the WWII HRS website. Each unit will have advantages and disadvantages: a good unit has members located near you and has events within your traveling capabilities. The impression must be affordable (see next paragraph for budgeting strategy.) and interesting. Most importantly, your future unit must have experienced and zealous members willing to support and mentor new recruits through comradeship and "loaner gear". The success of a new re-enactor is almost completely based upon their unit's ability to teach and guide him throughout the initiation period.

Tip: Before joining, interview and watch a unit participate at a public event.

WWII re-enacting is expensive. Prospective reenactors must be prepared to spend anywhere from \$1,000 to \$2000 to acquire the basic impression. Starting the hobby with at least enough money to purchase a uniform is essential, as well as a steady stream of funds so your impression can develop. You will need to create a budget based upon your financial situation. Keep in mind that although the majority of spending will be to build your impression some will need to be saved to pay for event fees.

Tip: Before purchasing an item for your impression ask for approval from the unit. Do not risk wasting money on items you cannot use. Impression quality and authenticity are paramount.

I believe the use of these two points has allowed me to enter the hobby of WWII re-enacting and build my impression, and that they will make any new member's journey easier.




