**Funding Request** - Camp Atterbury request of \$1500 is tabled. Weldonkreig has asked for \$2500 for their March, 2019 event. Dave Goodwin reported that they had 140 HRS members last year and have 230 or so registered so far for 2019. There was a discussion by the BOD about what type of funding the HRS can offer. CB made a motion that the BOD approve a \$600.00 request for the event which was seconded by DS. A BOD vote was taken and was approved by the BOD. The funding will be distributed after the event provides the necessary receipts.

## **New Business:**

**Heartland Event:** This event was approved by the BOD via e-mail and added as a HRS event

**Danville Funding Request:** They have asked for \$200.00 to cover porta-johns. CB made a motion to approve which was seconded by DS. A BOD vote was taken and the funding request was approved. JeffS will contact the event organizer and let him know about the approval.
