Commonwealth Rep: MR reported that he went through the list of Units with less than 5 members for 2019.

<u>First Canadian Para</u> has had no members for the past two years. MR made the motion to put the Unit on Probation and CB seconded the motion. A BOD vote was taken and the Unit will be put on Probation.

<u>2/25 Australian</u> Unit has 3 members in 2019 and none in 2020. MR made a motion to put the Unit on Probation, which was seconded by CB. A BOD vote was taken and the Unit will be put on Probation.

No. 10 Commando has had less members for the past two years. MR made the motion to put the Unit on Probation and CB seconded the motion. A BOD vote was taken and the Unit will be put on Probation.

Allied Rep: CV received an e-mail from the 34th Infantry Division, 135th Infantry Regiment D Company which wants to be disbanded.

CV reported that the 82nd Airborne Division 325th GIR, 3rd Battalion, F/K Co. reported they are going through a change in Unit CO.

2nd Infantry Division 23rd Inf. Rgt. I Co., has no members for 2020. JS will get in touch with David to see if he wants to stay as a Unit.

3rd Infantry Division 15th Regt. B Company has had less than 5 m3mbers the past few years. CV made a motion to put them on Probation, seconded by DS, and a BOD vote was taken.

Axis Rep: DS has been contacting those units that had less than 5 members last year. He was contacted that the 250th Infantrie Div, Azul; Ski Companyis interested in being disbanded.

Staff Reports

Membership Coordinator: Jeff Skender has mailed out all membership cards and Unit Reports to the UC's. There 629 members as of today.

Committee Reports:

S&A Nothing new other than what was covered in the VP Report.

Unit Commanders UC's are getting their membership lists monthly. Nothing else to report.

Vehicle Committee JimS and RK have not had a chance to work on the Vehicle Inspection Report. Tabled for now.

Old Business:

Amendment to Minor Age Member Rules: JS's goal was to streamline the Rules and try to get younger members involved. The proposed Rules were distributed to the BOD prior to the meeting for review. JS made the motion to approve the Proposal which was seconded by CB. A BOD vote was taken and the Proposal was approved. JS will send the proposal to the Unit Commanders Group for further comment before it is sent to the HRS membership for a vote.

New Business:

Event Cancelations/Postponed – Lockport was cancelled.

Scholarship: CB will post the Scholarship information on the FaceBook page.

CD renewal: The \$30,000 CD is up for renewal. JS asked whether we should renew it or move it to the checking account. DS made a motion to renew the CD, along with its interest, which was seconded by CB. A BOD vote was taken and was approved. The CD will be renewed for another year.

Open Comments: Wayne McCauley asked about the Edge as there hasn't been an edition since 2019. JS reported there is no one who has volunteered to take over the project. CV mentioned that he has heard from UC's that their members are asking why they should register with the HRS because there are no events and/or they do not see the value in the HRS membership. A discussion was held regarding the major cost the HRS has is insurance, which must be paid whether there are any events or not. MR suggested that the BOD perhaps explain to members what the financial health of the HRS is, so that perhaps the membership might better understand the need for dues whether there are events or not. MR further suggested that the BOD enforce the April 1st 5-member requirement that if a Unit does not have 5 members by April 1st, it automatically be put on Probation until they get their 5 members. A suggestion for some sort of discount be given for 2021 membership is something to consider in the future. The consensus was that could be further discussed later in the year. CB mentioned that the BOD and HRS should continue to let members know the value in the HRS and what the HRS does, such as providing insurance for events and providing funding requests for events.
