#### **Committee Reports:**

Scholarship Committee: DS will send out a note about the scholarship contest. JS to send DS a previously used. The deadline will be set in September.

WW1 Committee: DS reported that the WW1 event went very well. JS suggested that we open the membership to ask if they are also a WW1 unit member. There should also be a primary selection for WW1 as an era so that WW1 only reenactors can join the HRS. JeffS will be asked to look into that as an Event Brite choice on registration. RK discussed the issue of developing WW1 S&A standards as a subset of the HRS. RK and DS work on this developing issue.

Publications. JeffS and JS. Nothing finalized but JS had identified a few "lead" writers for the Edge as well as a designer for the Edge. We are still looking for someone to lead the Committee overall.

Governance Committee: MR, no report.

Vehicle Committee: RK reported a little on inspections and the work with the museum.

Civilian Committee. CV had identified four people who want to be part of the CC. Their biggest issue is authenticity standards for civilians. CV is also working on how to get more civilians involved in events.

## **Old Business:**

**Vehicle and Event Payout.** Logansport: RK mentioned that he thought those were handled as is identified on the Treasurers Report. Dundas, MN request for \$800.00 vehicle reimbursement was tabled as we are waiting for a receipt before making a decision.

**Covid Policy –** RK mentioned that the COVID Waiver should continue to be used for events. The BOD agreed to continue it as a requirement for events.

**Bylaw Vote and Election Results:** JS will forward (via email) the "official" results to RK for safe keeping. The By-Law amendments all passed and need to be added to the By-Laws. RK will add the new amendments to the By-Laws and have them, posted on the website.

#### **New Events:**

Cantigny Event. RK reported about the event and that it was approved as an HRS Event and the HRS will insure the event.

Rockford Update: RK gave an in-depth review of the Rockford Committee and its results so far.

CV reported on a few non-HRS events, such as: Greenwood, IN event put on by Bill Sheets, with planes, etc; the Vincennes, IN event in September; and the Bowman Field event in Louisville, KY in October, which is also an airplane event.

<u>Open Comments:</u> JS asked about the HRS sponsoring some sort of meal or such, as it has in the past. RK and DS reported that the Rockford Committee has discussed the issue abut not committed to anything yet.
