Old Business:

Reimbursment of Event Support for Market Garden (\$300), Kursk (\$300), and GD vehicles (\$500) have been approved. JSkender confirmed checks would be issued.

Rockford and Illinois Firearm laws: CB stated we have made our views clear on Facebook group. The HRS is not qualified to speak on legal issues, and members with questions about Illinois gun law and events should seek the advice of a lawyer.

New Business:

Rockford HRS Breakfast: CB inquired about status of HRS breakfast and if we had heard from 353rd ID about whether they would want to make the meal. WM asked how many members had eaten last year and how many HRS members attended Rockford last year. RK stated he would make inquiries of 353rd leadership and find out if they are will to make breakfast this year. He will also ask about how many HRS members attended the breakfast last year. CB stated we need to know soon. Vote on this matter has been tabled for more information.

Chippewa Valley Tactical: Approval of this event was requested by Robert Hodill from 3rd Gebirgs Div. CB motioned for this event to be approved as an HRS event. WM seconded. Event was approved by BOD vote.

Occupation and Rebellion tactical: Andrew Wurth and Tyler Brusseau attended meeting and outlined their proposed event. Occupation and Rebellion will be held May 13-14 2024 in Lucasville Ohio. The setting will be Ukraine 1944 and will consist of German forces opposing Partisans (Russian and Ukrainian). CB asked about how S&A would be handled. Andrew and Tyler assured the board safety inspections would be conducted prior to commencement of tactical and HRS rules and guidelines would be followed. CV expressed concern about how the current war in Ukraine would be handled. CB called for the Occupation and Rebellion tactical to be approved as an HRS event, CV seconded. Event was approved by BOD vote.

Eschweilerwald 44 tactical: CB stated Tom Comer from 2nd Panzer had applied for HRS approval for their upcoming tactical which will be held November 10-12, 2023 at Sommer Park in Peoria, IL. They have also asked for HRS funding in the amount of \$500 for park rental. CB stated he favors full funding of the

request. CB motioned to approve the event. JS seconded. Event was approved by BOD vote. CB motioned to table vote on funding until next meeting. Which was approved.

CB motioned to confirm that all outstanding approved funding requests will be paid. This was confirmed by BOD vote.
